 All food & beverage vendors must have a Health Permit from the Washoe County Health Department one month in advance to operate at Street Vibrations. Call 775-328-2648. You must present your Health Permit to the Show Manager upon arrival or you will not be allowed to set up.
 Vendors must carry insurance against damage and loss plus public liability insurance against injury and property of others, with limits in the amount of: \$1 million per occurrence and \$2 million aggregate, and name Roadshows, Inc. as additional insured on the policy.

Agreement

In signing this contract, I agree to comply with the rules and regulations printed on both sides of this contract. I understand exhibit locations and space assignment are subject to approval by Roadshows, Inc. and the city of Reno, and that every attempt will be made to place vendors in the desired space. However, the Show Manager reserves the right to assign space on a first come basis. I agree not to relocate or sell any merchandise outside the assigned space. I understand acceptance of moneys by Roadshows, Inc. under this contract is not binding if said money is returned before August 30, 2023 and understand that no refunds will be given after show begins.
